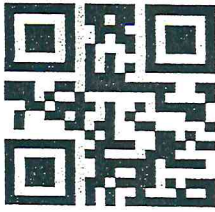

AMENDED ARTICLES OF INCORPORATION

OF

MINDANAO EDUCATORS MUTUAL BENEFIT ASSOCIATION, INC.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, all of legal age and majority of whom are residents of the Republic of the Philippines, have this day voluntarily agreed to form a non-stock and non-profit association under the laws of the Republic of the Philippines.

AND WE HEREBY CERTIFY:

FIRST: That the name of said Association shall be:

MINDANAO EDUCATORS MUTUAL BENEFIT ASSOCIATION, INC.

SECOND: That the purpose or purposes for which such Association is incorporated are:

- (1) Primarily, to provide its members certain benefits in case of sickness, disability or death of its members by accumulating funds through the collection of fees or dues from its members, at either stated or irregular intervals, as well as the accumulation and lending of money to its members, by lending the capital of the Association and such other funds as it may from time to time lawfully acquire from various member-borrowers on such personal security or security of personal property as may be agreed on between the Association and member-borrower, and by re-lending in like manner the funds arising from the loans when paid; but the Association shall not have banking or discounting privileges;
- (2) To foster brotherhood and mutual help and benefit among its members;
- (3) To promote the general welfare of its members and their families;
- (4) And to do such acts, things and undertake activities not otherwise prohibited by law which are necessary to help the members and for the accomplishment of the purposes for which the Association was organized.

Incidentally,

- (5) To acquire real and personal properties necessary for its operations;

- (6) To exercise all the powers and privileges under the law for the attainment of the above purposes, provided that any profit which may be obtained as an incident to its operations or power shall, whenever necessary be used in furtherance of the benefits of the members;
- (7) That the purpose for which it was created is one of those created under section 30 of the National Internal Revenue Code (NIRC) of 1997.

Any profit *obtained by the association as a result to its operation, whenever necessary or proper* shall be used for the furtherance of the purpose enumerated in the Article 11. subject to the provisions of the Title XI of the Corporation Code of the Philippines.

NINTH: That EUNICE C. LACSON has been elected by the Members as Treasurer of the Association to act as such until her successor is duly elected and qualified in accordance with the by-laws, and that as such Treasurer, she has been authorized to receive for and in the name and for the benefit of the Association all contributions (or fees) or contributions or donations paid or given by the members thereof.

TENTH: That we, in behalf of the said Association do hereby undertake to change its corporate name immediately upon receipt of notice or directive from the Securities and Exchange Commission that another corporation, association, partnership or person has acquired a prior right to the use of that name or that the name has been declared as misleading, deceptive, or confusingly similar to a registered name or contrary to the public morals, good customs or public policy.

ELEVENTH: That the Association shall comply with the rules and regulations of the Securities and Exchange Commission for non-stock corporations in the course of its operations.



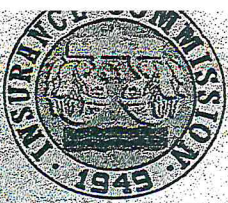
